

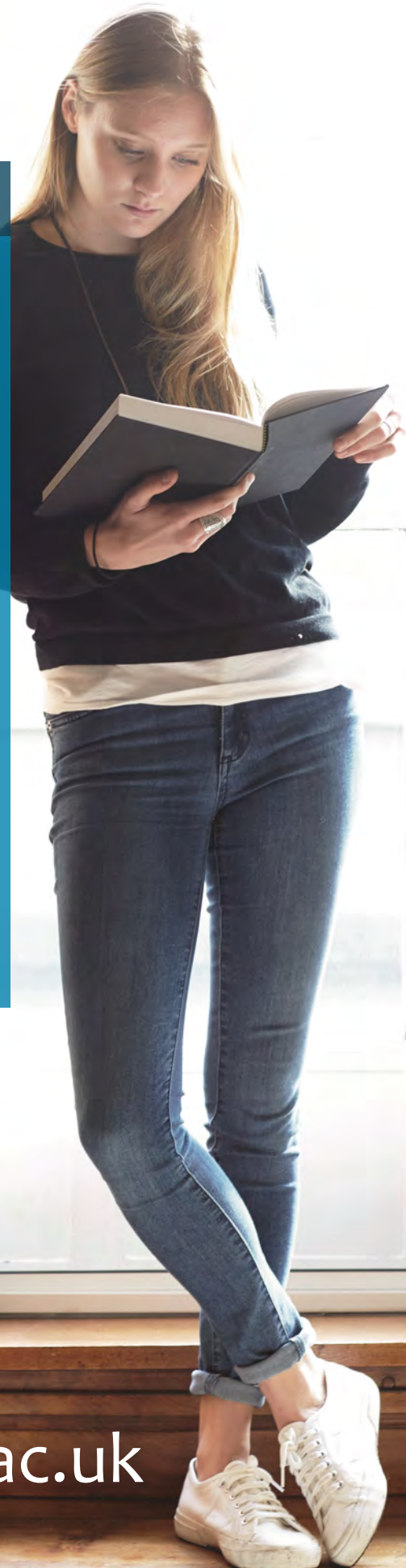

# What is the Online Library?

The [Online Library](#) is a Library service dedicated to supporting all students of the University of London's distance learning programmes.

The Online Library provides access to a range of legal resources similar to those available in a physical library.

All resources have been carefully selected and purchased because of their high academic quality and as such are more reliable than those freely available on the web.

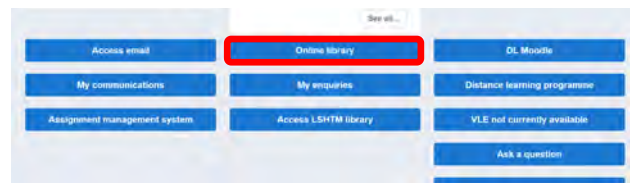
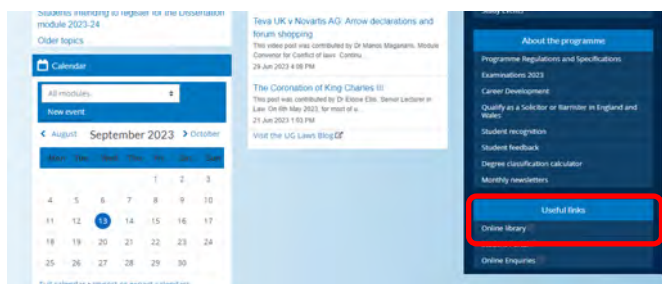
The Library is managed by a team of professional librarians who are available to provide help and advice.

## Why do I need to use the Online Library?

- To access high academic quality legal and multidisciplinary databases.
- Having access to superior academic content can help you obtain superior academic grades.
- Learning to use the library effectively will equip you with the information skills you need to succeed in your studies and in your career. It is also a qualifying law degree requirement.
- The Online Library is also a place to go to for [support](#). The Online Library is managed by a team of professional Librarians (including a Law Librarian), who are available to provide support with using the library via the [Online Library Enquiry Service](#).

- Statistics

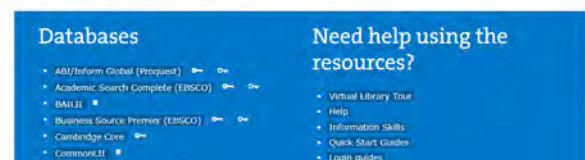
This material is stored in [databases](#).

**Databases** are collections of scholarly resources which have been carefully selected because they meet the resource needs of your programme. These quality authoritative sources are not freely available from the internet. The databases which are relevant to your programme are listed on the [Laws \(UG\) Study Programme gateway](#).



### Laws (UG)

Welcome to the Laws (UG) Study Programme Gateway.



The Study Programme gateway contains the course specific databases, resources, and support materials.

To access the Laws (UG) Study Programme gateway select [Study Programme](#) from the top navigation menu, then select [Laws \(UG\)](#) from the list of programmes.

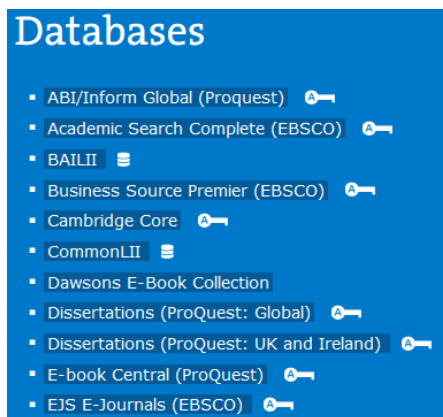


# Databases

## Accessing the Online Library

All Online Library databases are password protected.

- To log into the Online Library use the same username and password you use for the VLE.
- The exception is **Kluwer Arbitration** which requires an individual password which can be requested by completing the [Kluwer Account Request form](#).



The databases are listed on the left side of the [Laws \(UG\) Study Programme gateway](#):

Select a **database** to go to the **database page** which contains the login link, login guides, and quick start guides to help you get started searching the database. For example,

1. Select **Login** to log in with your student portal password.
2. A description of the database content.
3. **Login Guides** provide step-by-step login instructions. A list of all login guides is available on our [Login Guides page](#)
4. **Quick Start Guides** give guidance on searching the database

### HeinOnline



To login with your portal password, click the orange button and then select **University of London Online Library (Portal Login)**.



HeinOnline contains major full text collections with an American focus including: the Law Journal Library, covering over 2600 titles (including older issues of journals), the English Reports, the Legal Classics Library, the Treaties and Agreements Library, the Foreign & International Law Resources Database, and the U.S. Supreme Court Library.

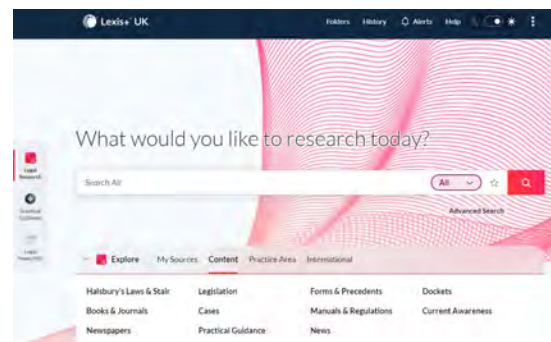

## Database overview

The key Online Library legal databases are:

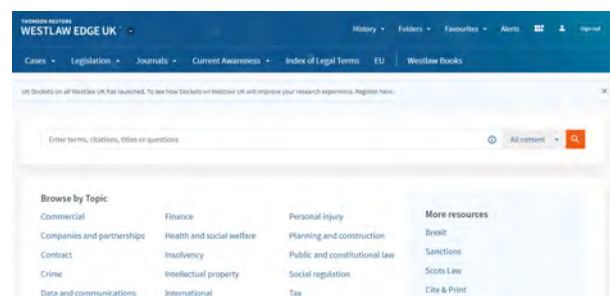
### [Lexis+](#)

UK cases, legislation, and journals. Extensive US and international materials. Search Lexis+ for the All England Law Reports and New Law Journal. Includes access to Halsbury's Laws of England.



### [Westlaw](#)

UK cases, consolidated legislation & over 100 full text journals. EU cases, treaties, and directives. Search Westlaw for articles from the Law Quarterly Review and Criminal Law Review and many others. Westlaw also contains the Legal Journals Index (abstracts of key legal journals) and the Index to Legal Materials (which includes Jowitt's Dictionary of English Law, Stroud's Judicial Dictionary of Words and Phrases and Jowitt's Dictionary of English Law).



### [vLex Justis](#)

UK cases and legislation (as enacted). Includes a powerful case citator to help you determine whether a case is good law. vLex Justis indicates where a case has been reported, and links directly to the law report in the Online Library legal databases.

### [HeinOnline](#)

Full text collections with an American focus, includes the Law Journal Library, which contains over 3000 journals (including older issues), and the Legal Classics Library.

# eBooks

## eBooks

### VLeBooks:

VLeBooks is one of the main Online Library eBook databases.

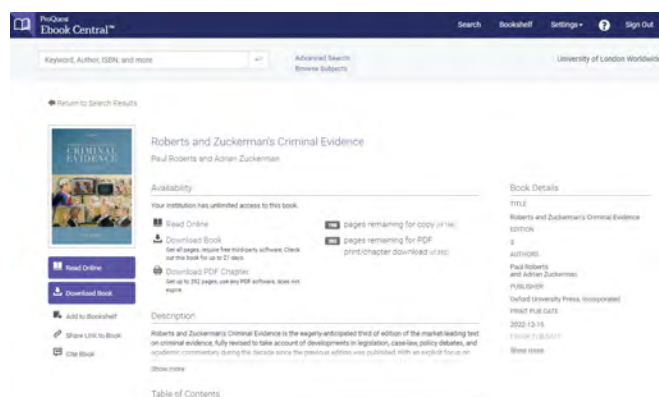


Access VLeBooks from your [Study Programme Gateway](#), or from the [eBooks page](#).

Search [VLeBooks](#) directly by author and title, or search [Summon](#) to search across all eBook databases at once.

### E-book Central (ProQuest):

E-book Central is another key eBook database.



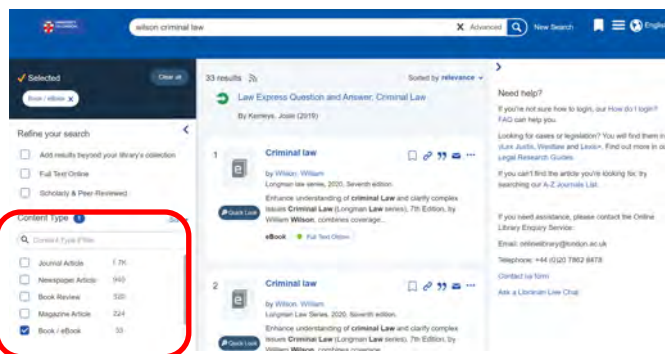
Log in from the [E-book Central](#) database page, or search [Summon](#) to discover the eBooks available.

If a book in E-book Central is not owned by the Online Library you can view a 5 minute preview after which you can suggest it for purchase by selecting the Request button and filling in the request form.

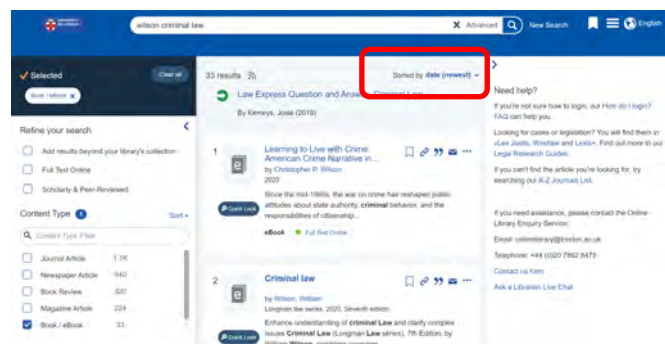
### Cambridge Core:

Cambridge Core contains a growing selection of law eBooks.

**Top Tip:** When searching Summon, if you retrieve too many results and do not see the book you are looking for, select the Content Type **Book / eBook** from the filter menu on the left side of the results page, to filter your results to eBooks only. This greatly reduces your results and makes it easier to find what you are looking for.



**Top Tip:** If Summon retrieves multiple editions of a book, you can sort your results to show the newest first. By default Summon displays results by relevance. Select the **sorted by:** drop down and change it to **Date (newest first)** to display the most recent editions first.



## Reading eBooks

You can read eBooks online within VLeBooks and E-book Central, or download them using Adobe Digital Editions.

When you download a book this is similar to borrowing it from a physical library. The download will expire after a set period, after which you can download it again as many times as you wish.

Some titles have a limit to the number of users who can access it at a time. In VLeBooks, if the book is being read by another user, you can join a 'queue', and you will receive an email when it is your turn to access the book.

# Searching the Online Library

## Searching the Online Library

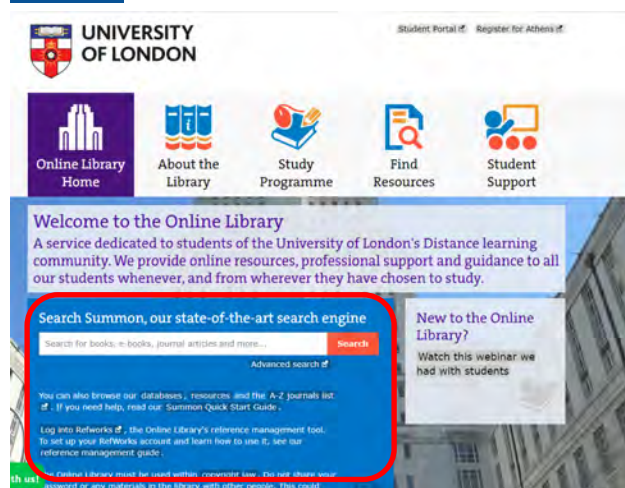
Access the databases from the [Laws \(UG\) Study Programme Gateway](#) and search them individually.

However, if you access the databases individually, you will only be searching the contents of that particular database. So, the Online Library provides search tools to help you to search across your databases and quickly locate your resources.

## Library Search Tools

The Online Library provides access to a number of resource discovery, or library search tools.

### Summon:



The Summon search box is available on the Online Library homepage at [onlinelibrary.london.ac.uk](http://onlinelibrary.london.ac.uk)

Summon is a good starting point for your Online Library research. Summon searches across most of the Online Library databases for journal articles, eBooks, newspapers and more, from a single search box. Select a Summon result to go directly to the database the item is available in. After logging in, some databases will direct you straight to the full text resource, while others direct you to the journal, where you can then search for an article within in.

Please be aware that Summon **does not** search for cases or legislation.

If you are looking for cases or legislation, you will find them in [vLex Justis](#), [Westlaw](#) and [Lexis+](#). Find out more in the [Legal Research Skills Guides](#)."

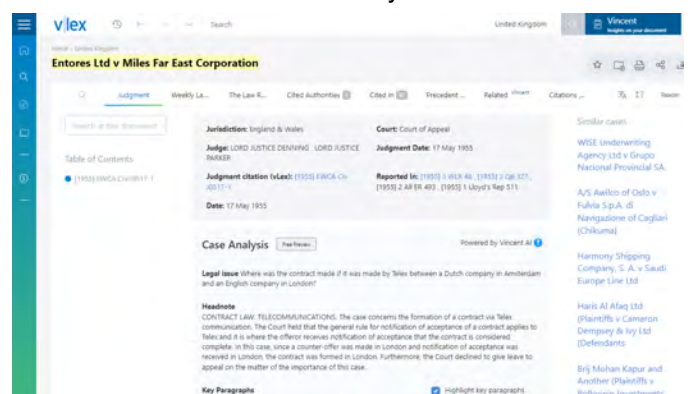
### vLex Justis:

vLex Justis is a single point of entry for your legal research.

vLex Justis contains UK legislation from 1235 (as enacted), with links to amending instruments. An extensive collection of reported, and unreported UK judgments and European Union materials.

vLex Justis contains a powerful case citator which cross-references case law, and legislation, helping you to find leading authorities and determine whether a case is good law.

vLex Justis lists the citations, and sources of cases and legislation in major online legal databases, and allows you to link you straight to the full-text where available in the Online Library databases.

### The A-Z Journals List:

Search the A-Z Journals List for the title of a journal, or law report, to find out which database it is in, and the years available.

Access the A-Z Journals List from the [Journals page](#).

Or from the Summon search box on the [Online Library homepage](#).

For example, to search for this journal article: **Gardner, S. (1992) "Trashing with Trollope: a deconstruction of the postal rules", 12 OJLS 170**

Either search Summon by the author and title of the article **OR**;

Search the A-Z Journals List to find out which database contains the journal.

Journals and law reports are often abbreviated, e.g. *OJLS*. To find out the full title search the [Cardiff Index to Legal Abbreviations](#).

A search of the **A-Z Journals List** for Oxford Journal of Legal Studies, shows that the 1992 issues are available in [JSTOR](#), and [HeinOnline](#).
