Five main categories of documents

BITs - Bilateral Investment Treaties: select a jurisdiction to view an overview of the Bilateral Investment Treaties (BITs) concluded between various states, including the full text document if available.

Conventions: this section lists the most important conventions relating to arbitration, for instance, the 1961 European Convention (Geneva).

Jurisdiction: select a jurisdiction to browse all content related to that jurisdiction.

Legislation: this category provides the text of laws for key countries. Old versions which are no longer applicable may still be included if they are useful for research.

Rules: this category is divided by most significant arbitral institution and subdivided into Rules, Models and Awards.
